## CONTRACT TERMS & CONDITIONS

- Haul out and boats are stored at owner's own risk. Water's Edge shall incur no liability for loss or damage while boats are hauled out and stored on Marina Property.
- The boat owner will carry \$300,000 liability insurance for his/her craft. MUST HAVE CURRENT INSURANCE ON FILE!**
- If a boat is owned by more than one person, the person on the contract will be held responsible for any debts due the Water's Edge Marina.
- All haul outs will be PRE PAID. Owner must be present during entire haul out process.
- Any damage to docks, water or electrical systems, etc. will be reported to the Water's Edge office so that repairs can be made. Please fill out Marina Repair request located in the main office.
- Boats cannot be plugged in when unattended, per fire code. If your boat is found plugged in you will be charge \$100 fee along with possible termination of contract.
- The boat owner will keep his/her area clean and free of debris. Failure to do so will result in additional charges and postponement or cancellation of services.
- The Winter season is defined as October 1 through March 31.
- Fees will not be prorated. NO REFUNDS.**
- All boats must be launched or otherwise off Water's Edge property by June 5, 2025. NO EXCEPTIONS! Failure to comply will result in late launch fees of \$25.00 per day. Please be advised this will be in full effect, and if not followed your contract will be terminated and police will be notified. Int.**
